



Good Standing Policy

The Canning Vale College Values of 'Respect for Self, Respect for Others and Respect for the Environment' are embedded into all aspects of the College. The rationale of Good Standing is to acknowledge those students who are able to consistently demonstrate these values and adhere to the College Code of Conduct. Maintaining Good Standing requires students to adhere to the school rules which have been derived from the Code of Conduct, outlined in the CVC Positive Behaviour Policy and the CVC Attendance Plan. Students who do not demonstrate these values or who fail to adhere to the College Code of Conduct risk the loss of Good Standing.

Student Code of Conduct at CVC

The student code of conduct defines the college's expectation of student behaviour, conduct and responsibilities. Students at CVC will:

- Follow all College rules and guidelines as set out in College Policy documents
- Respect the diversity of all individuals
- Model appropriate behaviour at all times and in all areas of the College
- Respect and value the College environment
- Respect the rights of others
- Actively listen to and follow direction from all staff
- Attend school, be punctual and prepared for class, every lesson, every day
- Wear the prescribed CVC College uniform appropriately at all times
- Model appropriate behaviour whilst in the community
- Consider the safety of others both inside and outside of the classroom
- Strive to achieve the academic, study and assessment requirements for each subject, to the best of their ability
- Support the school community by participating in assemblies and attending cultural and sporting events as required
- Seek support and advice if experiencing difficulties in any aspect of college life

Expectations of Good Standing

All Canning Vale College students commence the school year with 'Good Standing'. This entitles the student to the rights, responsibilities and privileges of every student within the College.

Maintaining Good Standing requires	
Attendance and Lateness	<ul style="list-style-type: none">• Regular (90%+) and punctual attendance at school.• Exceptions are applied for students that provide reasonable explanations for absence.
Acceptable behaviour	<ul style="list-style-type: none">• Student behaviour remains within the guidelines of the School Code of Conduct• Consistently models and demonstrates appropriate behaviour
Acceptable standards of dress	<ul style="list-style-type: none">• Students dress is expected to meet the standard as described by the 'CVC Uniform Policy' and the CVC Code of Conduct
Commitment to learning	<ul style="list-style-type: none">• Completion of requirements of their study program• Submission of homework, assignments and coursework• Working at a level which reflects the ability of the student

The withdrawal of Good Standing will result in the student not being able to participate in extra and co-curricular activities as decided by the Principal or delegate. Parents will be notified in writing if a student has lost Good Standing

Loss of Good Standing

When students do not meet the Colleges' expectations or do not adhere to the school's Code of Conduct the following steps will occur as required:

- Staff will raise the concern with Student, Parent, Head of Learning Area, other staff as required
- Interactions and information recorded on SEQTA
- Student Support Staff will discuss loss of Good Standing with Parent
- Correspondence sent to parent informing them of loss of Good Standing
- A plan is developed between Student Engagement and Support Staff and the Parent/ Student to work towards the reinstatement of Good Standing
- Decision to reinstate Good Standing is made by the Principal or their delegate.
- Students will be given ample opportunity to regain Good Standing.
- The names of students who have lost Good Standing will be displayed on the SEQTA home screen to inform staff that these students may only participate in core curriculum activities.

Students will Lose their Good Standing for a minimum of 3 weeks in the case of

Absence/ Lateness

- Students are persistently late to school without satisfactory explanation *even after intervention*.

Dress Code

- Persistent non-compliance with the School Dress Code *after intervention*

Unacceptable Behaviour

- Repeated breaches of the Schools Positive Behaviour Support Plan

Commitment to learning

- Repeated failure to meet course requirements after intervention

Suspension

- Students will automatically lose Good Standing as a result of a suspension from school
- A plan to reinstate Good Standing and review dates are put in place and documented as part of the return from suspension process
- Review dates and planning will be commensurate with the seriousness of the breach of school discipline

Consequence of Loss of Good Standing

- The student is unable to participate in extra-curricular activities for the time that they have lost their good standing
- The duration of loss of Good Standing and review points is to be determined by the by the Principal or their delegate.
- In exceptional circumstances the Principal may choose to exclude students from participating in co-curricular activities, in which case alternative arrangements will be made to ensure students receive the information required.
